

ORDINANCE 11-11

TO LEVY A MUNICIPAL MOTOR VEHICLE LICENSE PLATE FEE PURSUANT TO SECTION 4504.172, OHIO REVISED CODE

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF UHRICHSVILLE, OHIO:

SECTION I: There is hereby levied an annual license plate tax upon the operation of motor vehicles on the public roads or highways pursuant to § 4504.172, Ohio Revised Code, for the purposes of paying the costs and expenses of enforcing and administering the tax provided for in this section and to provide additional revenue for the purposes set forth in § 4504.06, Ohio Revised code and to supplement revenue already available for such purposes.

SECTION II: Such tax shall be at the rate of Ten Dollars (\$10.00) per motor vehicle on each and every motor vehicle the district of registration of which, as defined in § 4503.10, Ohio Revised Code, is the City of Uhrichsville, Ohio.

SECTION III: As used in this Ordinance, the term "motor vehicle" means any and all vehicles included within the definition of motor vehicle in § 4501.01 and 4505.01, Ohio Revised Code.

SECTION IV: The tax imposed by this ordinance shall apply to an be in effect for the registration year commencing January 1, 2012, and shall continue in effect and application during each registration year thereafter.

SECTION V: The tax imposed by this ordinance shall be paid to the Registrar of Motor Vehicles of the State of Ohio or to a Deputy Registrar at the time application for registration of a motor vehicle is made as provided in § 4503.01, Ohio Revised Code.

SECTION VI: All moneys derived from the tax hereinbefore levied shall be used by the City of Uhrichsville for the purposes specified in this ordinance.

SECTION VII: This ordinance shall become effective from and after the earliest date allowed by law and is not an emergency measure.
